NARRATIVE

ON 09/24/2013 DETECTIVE DERRICK WILLIAMS OF THE NEW ORLEANS POLICE DEPARTMENT SPECIAL VICTIMS SECTION INVESTIGATED THE SEXUAL ASSAULT OF A YEAR OLD FEMALE.
