NARRATIVE

ON 09/24/2013 DETECTIVE DERRICK WILLIAMS OF THE NEW ORLEANS POLICE DEPARTMENT SPECIAL VICTIMS SECTION INVESTIGATED THE SEXUAL ASSAULT OF A [REDACTED] YEAR OLD FEMALE.

THE VICTIM STATED SHE CONSUMED A LARGE AMOUNT OF ALCOHOL ON SUNDAY SEPTEMBER 23, 2013. THE VICTIM STATED SHE WENT TO A COUPLE BARS WHERE SHE CONTINUED HAVING ALCOHOLIC BEVERAGES. THE VICTIM STATED SHE MET THE PERPETRATOR AT ONE OF THE BARS, AND HE TOOK HER TO HIS APARTMENT AND SEXUALLY ASSAULTED HER. THE VICTIM STATED SHE DID NOT CONSENT TO ANY SEXUAL ENCOUNTER.

THE INVESTIGATION WAS OPEN AND ONGOING.
